Overview

Does Germany have 5G?

The Bundesnetzagentur has updated its mobile network coverage map to provide information on 5G in Germany for the first time. The Bundesnetzagentur's data show that by the end of October 2021, over 53% of the country was already covered with the latest mobile communications standard, 5G, from at least one provider.

Who is a 5G provider in Germany?

Germany: Deutsche Telekom, Vodafone Germany, and Telefónica (O2) are the key players. Deutsche Telekom and Vodafone have established significant 5G coverage, focusing on the 3.6 GHz spectrum, although the 3.5 GHz range is less commonly deployed due to regulatory constraints. O2, while covering large urban areas, is still expanding in rural regions.

What percentage of the country has 5G coverage?

5G coverage by at least one network operator has increased in recent months to around 79% of the area of the country (as at October 2022). When the first data were collected in October 2021, coverage was at around 53%. Current data show that the 5G coverage achieved by individual mobile operators ranges from about 37% to 55% of the country.

What is the role of Tower Companies in 5G?

The rollout of 5G relies heavily on partnerships with tower companies, which are essential in constructing and maintaining the physical infrastructure needed to support these networks. In Germany, Belgium, and The Netherlands, the role of tower companies is paramount:.

Is 5G available in Belgium?

Belgium: The Belgian government has been slower in spectrum allocation, especially in the mid-band range (3.4-3.8 GHz) essential for 5G. Proximus,



Orange Belgium, and Telenet are actively rolling out networks, but coverage remains limited, with a particular focus on urban areas and strategic industrial zones.

Does 5G have a service provider obligation?

The award rules for nationwide 5G spectrum do not contain a so-called service provider obligation. That means that 5G mobile network operators are not obliged to sign access agreements with service providers unless ordered to do so by the Federal Network Agency. 12.
