How can I hold electric companies accountable?

Explore your legal options for holding electric companies accountable, including breach of contract and class action lawsuits. Disputes with electric companies often stem from service interruptions, billing discrepancies, or alleged misconduct.

What documents should I collect if my electric bill is disputed?

Some common documents you'll want to collect include: Most recent bill: Collect your current bill from the electric company, and identify the charges you're disputing. Account history: Round up all your previous bills, payment confirmations, bill adjustments, and any earlier documentation related to the dispute.
