What are NREL's quarterly solar industry updates?

NREL's quarterly solar industry updates provide information on trends within the solar industry. These quarterly updates cover an array of photovoltaic module and system technologies as well as energy storage and concentrating solar power. The quarterly solar industry updates often cover: Updates on related government programs and policies.

How many solar modules have been added in 2024?

Since the IRA's passage, more than 95 GW of manufacturing capacity have been added across the solar supply chain (from facilities announced pre- and post-IRA), including nearly 42 GW of new module capacity. U.S. c-Si manufacturers added significant capacity in the first half of 2024.
