Overview

What is the tariff rate for imports from India?

The current tariff rate for imports from India is 25%. However, this rate can vary depending on the specific product category and any applicable trade agreements or exceptions. How do India tariffs affect import costs?

India tariffs directly increase the cost of importing goods by 25% of the product value.

What is the tariff structure on Indian goods?

The tariff structure on Indian goods combines a baseline 10% duty with a 25% reciprocal tariff, which was announced by Trump on April 2, 2025, and an additional 25% tariff effective from August 27, 2025. Unlike China, which faces a 30% tariff, or Vietnam and the Philippines at 20%, India and Brazil face the highest rate of 50%.

Why are India's exports at risk from US tariffs?

Because of this tariff, the sectors like textiles, gems and jewellery, leather, marine products, chemicals, and auto components face significant exposure, with 55% of India's US-bound exports at risk. The tariffs threaten India's \$434 billion export engine, with \$87 billion directed to the US, equivalent to 2.5% of India's GDP.

What is the US tariff on India?

The US announced a 26% tariff on Indian goods, later adjusted to 25%. A 10% baseline tariff on all imports, including India, was implemented. The 16% nation-specific tariff for India was delayed for 90 days until July 9. The delay period for nation-specific tariffs extended to August 1.

What is a 50% tariff on India?

The 50% tariff on India refers to a U.S. policy imposing up to 50% import duty



on Indian goods, implemented in two phases of 25% each, citing India's continued purchase of Russian oil. It significantly impacts sectors like textiles, gems, jewellery, and auto parts, potentially reducing India's GDP growth and export competitiveness.
